If access to the full-text is restricted, CABI would very much appreciate your supplying us with either id/password access or implementing access for IPs 194.131.255.12 and 203.34.246.178 (primary) and 203.56.241.178 (secondary) for the purposes of abstracting and indexing the publication in the CABI databases. Obviously, this is not an issue with regard to Open Access titles. CABI will utilise any alerting facility available on the website to alert us to newly published content. If no alerting facility exists on the website, indexing would be greatly assisted by your sending an email to [cabialerts@cabi.org](mailto:cabialerts@cabi.org) whenever a new issue is published - thank you.

CABI is a not-for-profit, international treaty organisation, dedicated to the dissemination of scientific knowledge. We produce two abstract databases in the applied life sciences: CAB Abstracts and Global Health. Our organisation has a long established reputation of indexing scientific literature, with electronic archives containing records for literature dating back to 1913. The CAB Abstracts and Global Health databases are used by Government and International agencies, academic institutions and commercial organisations worldwide to search and identify relevant literature, and so indexing coverage helps to promote the visibility of indexed titles to global users of the databases. Database users can easily alert themselves to relevant articles in their field of interest, which in turn results in them acquiring the full-text from the original publication source. The journal url and DOI (where available) are included in the CABI index record for this purpose. Indexed publications are listed in the 'Serials Cited' list on the CABI website, which is updated quarterly, and CABI would invite you to cite your journal as being indexed in the Global Health and CAB Abstracts databases.
